



## CONTEST RULES

The “Create your Centris.ca account” contest begins on September 1<sup>st</sup>, 2021 and ends on September 30<sup>th</sup>, 2021, the deadline for creating your account. The draw will take place on October 1<sup>st</sup>, 2021 at 11 a.m., at Société Centris Inc., 600 chemin du Golf, Montreal, Quebec H3E 1A8.

#### ELIGIBILITY

This draw is open to all Centris.ca users who have reached the age of majority. Employees of Société Centris Inc. are excluded. This draw is subject to applicable federal, provincial, and municipal laws and regulations. Also excluded are users creating an account using an Apple ID (with iOS 14) or a Facebook ID (on Apple devices with iOS 14), and who have chosen not to share their email address.

#### HOW TO PARTICIPATE

You are automatically eligible for the draw when you create a Centris.ca account between September 1<sup>st</sup> and 30<sup>th</sup>, 2021 or If you are a Centris.ca account holder on the day of October 1<sup>st</sup>. #### PARTICIPATIONS
